BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE

Assumption of Risk:

1) I the undersigned wish to play OUTDOOR PAINTBALL AT CAMP COMBAT. I recognize that playing OUTDOOR PAINTBALL AT CAMP COMBAT. (hereinafter called the "game") involves certain risk. Those risks include but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the game and injuries from tripping or falling over obstacles in the game playing field. In addition, I recognize that the exertion of playing the game could result in injury or death.

2) Despite these and other risks, & fully understanding such risks, I wish to play the game and hereby assume the risks of playing the game. I also hereby hold harmless the "sponsors" and hereby indemnify them against any and all claims, actions, suits, procedures, costs, expenses (including attorneys fee's and expenses), damages and liabilities arising out of, connected with or resulting from my playing the game, including without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of such equipment. I hereby release the sponsors from any and all such liability and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the sponsors that I am in good health and not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the game, I further certify that I am 18 years of age or older.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, & INDEMNITY AGREEMENT

In consideration of participating in the "game" I hereby agree as follows:

1) TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future have against CAMP COMBAT their directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as "the releasees").

2) TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, or expense that I may suffer or that my next of kin may suffer as a result of my participation in OUTDOOR PAINTBALL AT CAMP COMBAT due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;

3) TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to, any third party, resulting from any participation in OUTDOOR PAINTBALL AT CAMP COMBAT; and

4) That this agreement shall be effective and binding upon my heirs, next of kin, executors administrators and assigns, in the event of my death.

I HAVE READ AND UNDERSTAND THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
